- A. Review and approve previous meeting minutes:

  MOTION TO APPROVE minutes of last meeting by Nate, second by Bart. All in favor.
- B. Scott Bullock- Lot adjustments are done by the county. WCD looks at where the septic permits are. Simplest resolution- WCD convince to transfer the septic permit from one parcel to another parcel. Tina Esplin said the Engineers cannot and the current board on the WCD may not do it. Lot line adjustment is another alternative, this does not go through the WCD. The county wants fewer permits.
